Kevin Boette and Adam Lavallee raised concerns over the accuracy and format of information provided by the SAU since August. The new business administrator was given the formats that the Budget Committee would like to see but has not been following the guidance. Dennis Golding stated that he only has confidence in the accuracy of only a few numbers presented so far. Committee discussed the importance of accurate information in the budgeting process and that it is almost November and we still aren't confident in the process or the staff supporting the process. Since personnel matters fall in the purview of the School Board, Chairman Browne will raise concerns during the joint session.
