**VERIFICATION OF LEGAL RESIDENCY**

To be enrolled in an SAU63 school, student must reside in Wilton or Lyndeborough, New Hampshire. New Hampshire State Law states that no student who lives outside the district may attend school without consent of the School Board. The fact that an individual pays taxes to a district but has an established residence elsewhere does not extend the privilege of attending local schools.

Schools in SAU63 include: Florence Rideout Elementary School, Lyndeborough Central School and Wilton-Lyndeborough Middle School-High School.

If a student registers in an SAU63 school and is found to live outside of the district, the parent or guardian will be held responsible for payment of tuition proportionate with the number of days in attendance. If at any time during the year there is a change in family status, such as divorce, marriage, or a change in guardianship, parents are required to contact the school and provide legal documentation of these changes. The school district may request residency documentation at any time during the school year.

Parents who intend to move into the community during the school year may request enrollment of their children prior to the establishment of residence, giving written notice as to the anticipated date of residence. Tuition will be waived at the discretion of the school board.

*The penalty for perjury is a Class B felony with a maximum sentence of imprisonment not to exceed (7) years and/or a fine not to exceed \$4,000.*

- Guardianship – Proof of legal guardianship/divorce/separation (copy of parenting plan) if applicable
- Court Placement (copy of court decree)
- Social Service papers (AFDC, Social Security, Homeless Shelter Verification)
- Student affidavit for 18-year old or Emancipated Minor (attach document)
